The Council interviewed five candidates for the position of Town Administrator.

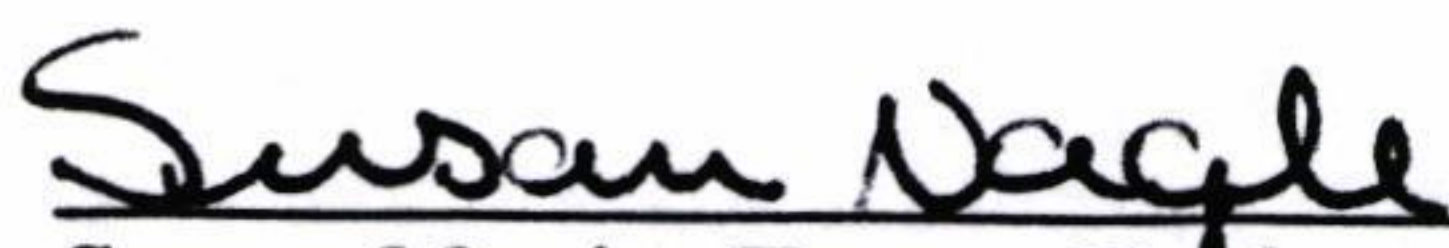
ACTION TAKEN: No action taken.
