On a motion made by Eddie Bowman and seconded by Joe Norman a Public Hearing is scheduled for March 17, 2009.

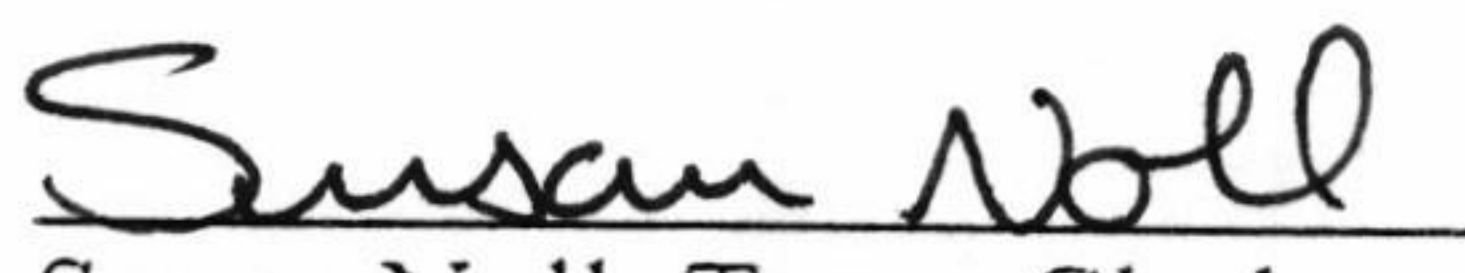
TOWN HALL MEETING: Mayor Austin asked if anyone signed up to speak at the Town Hall meeting.

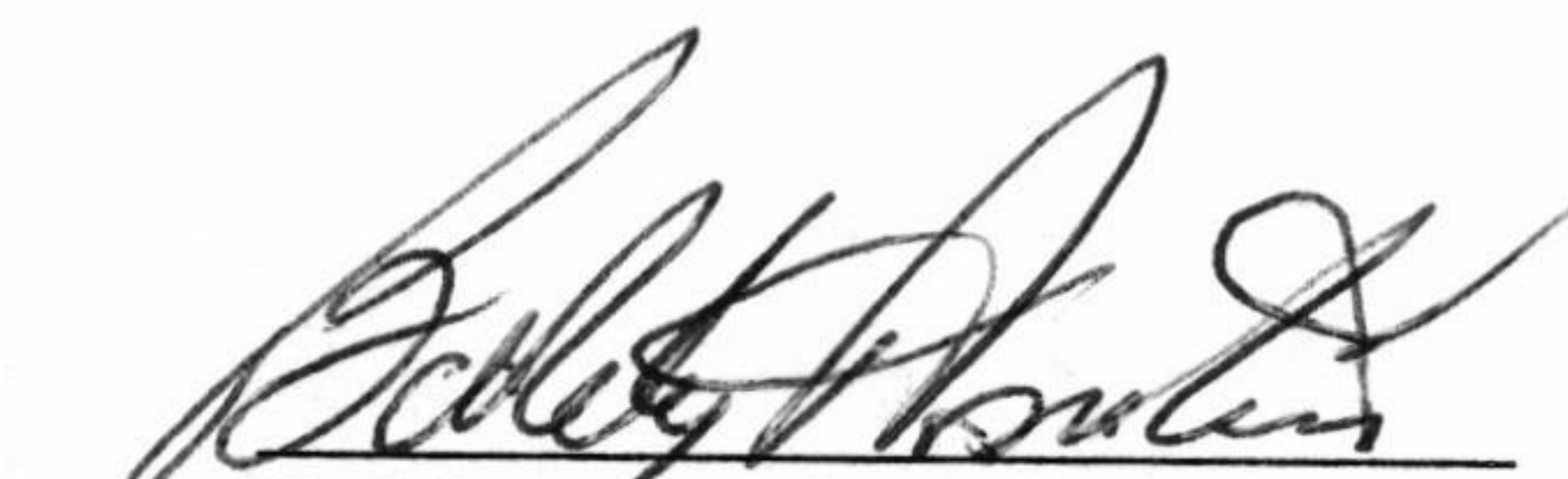
Mr. Johnny Wilson spoke about lowering the speed limit on Dry Ponds to 35 MPH.
